Saturday June 25th, 2011 at York School, off Highway 68, Monterey, CA
Same location as our July 15-17 trial!!! Great way to check out and train at our new trial site!!!!

9:00am – 2:00pm

PRE-ENTRIES \$6.00 PER RUN

DAY-OF ENTRIES TAKEN FROM 8:15 AM TO 10:30 AM; \$8.00 per run

SMART members pay \$5 pre-entry or day-of entry

Pre-entries close June 20, 2011

First run starts at 9:00 AM

CLASSES: Novice and Advanced/Masters Standard and Jumpers 8" 12" 16" 22" 26". Courses will be nested.

Walk-thru starts at 8:30 A.M. First run starts at 9:00 AM. Jump heights will cycle small to tall so you will have multiple opportunities to run. Within a jump height, running order will be first come, first served (queue at gate when you hear gate steward calling your jump height). Maximum time limits: 90 seconds in Standard ring, 60 seconds in Jumpers ring.

Requirements: This match is designed to prepare your dog for competition. Your dog should be at least one year old, have at least 6 months of agility training, be able to perform all obstacles safely, have a good recall, and be nearly ready to compete (talk to your trainer about what your dog is ready for). Any dog can run at any jump height (Great Danes at 12", if you like). Treats and toys are allowed in the ring, but PLEASE do your best not to drop food that will distract other dogs! Dogs must run collarless or in flat buckle collars, no attachments; dogs may not run with leashes on. No equipment familiarization. **Limited shade so bring shade, an X-pen or crate, and treats and water for your dog.**

Prohibited and grounds for excuse without refund: Dogs that are aggressive in any way toward people or other dogs; any harsh corrections, either physical or verbal; bark collars; or dogs that bark *excessively* in crates or cars.

Food: Coffee and breakfast type items will be available. Water will be available but you will need to bring your own bottle. SMART water bottles will be available to purchase. Bring your own lunch.

Directions to York School:

From Highway 101: take the Highway 68 exit toward Monterey. Travel west on Highway 68 past Toro Park, Los Laureles Grade, Laguna Seca Raceway, and Laguna Seca golf course until you reach the signal light at York Road. This will be about 10 miles. Turn right and proceed up the hill. The driveway to the School will become visible shortly after York Road rounds to the right at the top of the hill. Look for the big York School sign. You can't miss it.

From Highway 1: Travel east on Highway 68 driving past Monterey Airport, the junction with Highway 218, and Ryan Ranch Business Park until you reach the signal light at York Road. This will be about 3.5 miles. Turn left and proceed up the hill. The driveway to the School will become visible shortly after York Road rounds to the right at the top of the hill. Look for the big York School sign. You can't miss it.
